



SKILLED NURSING FACILITIES

Thank you for trusting your care to Keck Medicine of USC during your hospital stay. Your care team has determined that you would benefit from additional medical care at a skilled nursing facility (SNF).

It is your right as a patient to choose where you receive your post-acute care. Choosing a post-acute care provider can feel overwhelming. We want you to know that Keck Medicine of USC works closely with select Skilled Nursing Facilities in our Post-Acute Care Collaborative (PACC). These Skilled Nursing Facilities were chosen because they met certain quality and clinical criteria. We also work together on shared goals related to improving quality, communication and patient experience.

WHAT IS A SKILLED NURSING FACILITY?

Once you're ready to leave the hospital, you have different choices for your care. It's important to know about these options so you and your care team can decide what's best for you.

Nursing homes are facilities for people who qualify and meet clinical criteria for 24-hour care. Most nursing homes provide both short-term and long-term care:

- Short-term care for people who need rehabilitation after surgery, like physical therapy after a hip or knee replacement
- Short-term care for people who need skilled nursing to recover from an illness
- Long-term care for people who need help with activities of daily living, like bathing, dressing, or eating

After being in the hospital for an accident, serious illness or surgery, patients may need additional medical, nursing and personal care. A SNF features doctors, nurses, rehabilitation specialists, and other medical professionals and activity programs — all to ensure you get the level of care you need.

The nursing homes listed are certified by Medicare and/or Medicaid.

Providers participate in the Keck Medicine of USC PACC on a voluntary basis with no financial incentives for either party.

You are not required to select a provider from the Keck Medicine of USC PACC. A list of all Medicare Certified organizations in your geographic area of choice, including providers not in the Keck Medicine PACC, is provided to you.

CMS quality ratings are part of our process in selecting the organizations on this list. When a PACC partner's star rating changes, our team works closely with the partner to create a detailed performance improvement plan. Please be aware that some insurance companies have contracts with specific providers, suppliers, and facilities, which may affect the post-acute provider you can use. If you choose a post-acute provider or service that is not covered under your insurance plan or not participating in Medicare, you may be responsible for the cost of care.

If you are enrolled in a managed care organization, you should check whether your chosen provider is covered by your insurance plan before you pick them.
